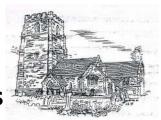


The Parochial Church Council of the Parish of St. Weonards 2021 Report & Accounts

Aim and purposes

St. Weonards Parochial Church Council (PCC) has the responsibility of cooperating with the incumbent in promoting in the ecclesiastical parish, the whole mission of the Church, pastoral, evangelistic, social and ecumenical. The PCC is also responsible for the maintenance of the church and churchyard at St Weonards.

Objectives and activities

The primary object of the PCC is the promotion of the Gospel of our Lord Jesus Christ according to the doctrines and practices of the Church of England. The PCC is committed to enabling as many people as possible to worship at our church and to become part of our parish community in St. Weonards. The PCC considers the pattern of worship in the parish and across the St. Weonards benefice and makes suggestions on how our services can involve the different groups that live within St. Weonards and neighbouring parishes. Our services and worship seek to put the Christian faith into practice through prayer and scripture, music and sacrament.

When planning our activities for the year, we have considered the Charity Commission's guidance on public benefit and the supplementary guidance on charities for the advancement of religion. In particular, we seek to proclaim the Good News of God's Kingdom and grow disciples of Jesus Christ, encouraging people to live out their faith by sharing God's love in our community and the world through:

- · worshipping God and praying for His help and guidance;
- caring and serving people in all life's situations;
- recognising and responding to those in need;
- inspiring and learning through each other's strengths and gifts;
- working to safeguard the integrity of creation

so that in all our activities we show Jesus Christ to those around us.

To facilitate this work it is important that we maintain the fabric of St. Weonards Church.

Achievements and performance

Context

2021 was another unusual year due to the COVID-19 pandemic, which continued to restrict our usual ways of working and patterns of worship. Our incumbent, Revd Elizabeth Cathie, took early retirement on 30 April 2021.

St Weonards benefice was suspended from 15 May for a period of up to five years, to allow the Ross & Archenfield Deanery leadership team to develop a deanery pastoral plan.

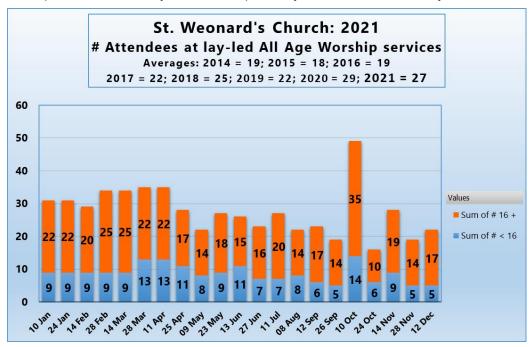
Worship and prayer

As the year progressed, our collective worship gradually shifted back towards more services in church (with social distancing and mask-wearing) alongside online 'Zoom' services. We are very

grateful to our Associate Minister Revd Dr Frances Phillips for leading benefice Communion services on Zoom on the 1st Sunday of each month, and preparing some pre-recorded YouTube services.

Without regular services in church, once again it is not easy to be precise about the breadth of our worshipping community, but we estimate this remains around 38 people including 8 children and young people. The electoral roll was refreshed in 2019 and the number on roll then was 29, of whom two live outside the parish; we estimate the electoral roll reduced to 21 in 2021.

We continued to hold informal lay-led 'All Age Worship' services at 10.00am on the second and fourth Sunday of each month. We were delighted to welcome other worshippers of all ages from across the benefice and beyond at these services. Attendance reached a peak of 49 on 10 October for an All Age service with baptism (35 adults and 14 children and young people), and averaged just under 27 across the year (>18 adults + >8 young people). A small part of the increase in 2021 came from worshippers in neighbouring parishes joining us online. Following the installation of wi-fi in the church on 6 October, we started streaming some services live via Zoom, which was greatly appreciated by those at home. Four of our All Age services were with Communion, thanks to visiting officiants in the form of Bishop David Thompson, Archdeacon Derek Chedzey, Revd Julian Reindorp, and Revd Tiffany Jackson (stipendiary curate at Ross-on-Wye).



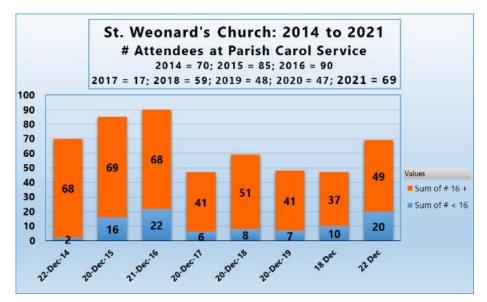
We were unable to resume the Coffee, Cake and Worship services that had been held on Thursdays each month prior to COVID.

However, we were delighted to host two weddings in July, when we privileged to witness to marriages of Edward Bowen and Elizabeth Sprackman, and James Davies and Isobel Partridge. In August we celebrated with the family of Megan Middlecote who was baptised by Revd Julian Reindorp during our All Age service.

Many hundreds of people came to remember the lives of three of our well-known parishioners: Florence Hayward (July), Joan Cole, and Ian Pugh (September). In October, we welcomed friends and family of Bill Taylor for a service of thanksgiving for his life. Bill, who used to live with his wife Margaret in Orcop, was an enthusiastic bell-ringer who once taught our current Tower Captain, Peter Hallewell.

Other special services included:

- Harvest festival (attended by 13 children + 50 adults);
- Parish carol service (20 + 49);
- Christmas Eve crib service (19 +30);
- Christmas Eve 'midnight' communion led by Bishop Richard Jackson (6 + 40).



There has also been a small group meeting online fortnightly to pray for our benefice, churches and local communities.

Caring & serving and responding to community needs

Revd Elizabeth Cathie and Revd Dr Frances Phillips provided pastoral support across the benefice, and we thank them for their dedication to many in our community. We have continued to offer practical support in the year to the OWL Good Neighbour Scheme, and have made collections for the Hereford Food Bank.

Safeguarding the integrity of creation

As a church, we seek to respond to the fifth Anglican 'mark of mission', to 'strive to safeguard the integrity of creation and sustain and renew the life of the earth.' Following our **Eco Church**¹ bronze award in 2020, we have continued to try to work out and integrate the core themes (Worship & Teaching, Buildings, Land, Community & Global Engagement, and Lifestyle) into our common life as a church. We had an environment-focused '**Climate Sunday**' theme to our All Age service at the end of the COP26 summit in November, using the Christian Aid 'River of Prayer' resources to reflect on those impacted by the climate crisis and to pray for those able to implement change.

St Weonard's Church also featured in the May 2021 edition of A Rocha UK's Root & Branch magazine.

Volunteers

Choral and organ music continue to form an integral part of worship in our services (when we're in church), and the parish and wider benefice is enormously grateful to Richard Mynors for the commitment and professionalism that he brings to all aspects of our church music. Due to COVID restrictions, there were limited opportunities for the benefice choir to get together, but Bishop Richard Jackson was delighted with the singing at the Christmas Eve communion service. We're also grateful to Richard for leading our worship through piano accompaniment during online benefice services, and recordings for YouTube.

Many thanks to our many volunteers:

- our skilled flower arrangers who make the church so lovely, organised by Gillie Hallewell;
- people who welcome congregations;
- those who prepare the communion table and wash the church linen;
- the Lewis and Williams families for providing refreshments;
- all those who have contributed behind the scenes for the benefit of the community Stephen Herbert for maintaining the St. Weonards benefice and A Church Near You websites and St Weonards Church Facebook page, Alex Herbert for leading worship and preparing the 'MailChimp' e-newsletters; David & Ginnie Thornley for in keeping an eye out for visitors to the church; Laura Pritchard, Marina Heathfield and Alžbeta Taylor for the regular cleaning; Tracy Knights for maintaining the churchyard in excellent order, and Muldowney family for helping to clear the church roof valley gutters and assisting with ongoing repairs.

We would like to express our particular thanks to our hard-working Treasurer and Gift Aid Officer Stephen Herbert, our Secretary Fiona Mynors and our Churchwarden Richard Mynors.

Safeguarding

The PCC has adopted the Church of England's 'Promoting a Safer Church: Safeguarding Policy Statement', and ensures that safeguarding is a standing order agenda item at every meeting. We are grateful to our Parish Safeguarding Officer, Fiona Mynors, for her work in this key area. The PCC considers that it has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016 to have regard to the House of Bishops' guidance on safeguarding children and vulnerable adults.

Deanery & Diocesan Synod

We thank Richard Mynors for acting as our deanery and diocesan synod representative. This role provides an important link between the parish and wider church structures.

Mission & outreach

We aim to share God's love in our community and the world and show Jesus Christ to those around us in practical ways through tithing, giving at least 10% of our voluntary income to mission work

outside the parish. Our principle is to give to Christian organisations working at diocesan, national and international levels. In 2021, the PCC made gifts of £400 to Herefordshire Vennture², Kintsugi Hope³, A Rocha UK⁴, Christian Aid's Global Hunger Appeal⁵, and the Hereford Diocesan Board of Finance's Train-a-Priest fund for ordinands at St Mark's Theological College in Dar es Salaam, Tanzania⁶. The PCC also made a donation of £50 to the Herefordshire Historic Churches Trust.

Ecumenical relationships

The church's joint witness alongside Baptist and Methodist congregations within neighbouring parishes in effect was paused in 2021 due to COVID-19 restrictions, but we have continued to welcome families from these congregations in our All Age services.

Fundraising events

As the coronavirus pandemic restrictions started to be lifted in the late spring, we decided to press ahead with a Garden Open which was held in the grounds of Treago, thanks to the Herbert family. It seemed that lots of people were glad of the opportunity to meet again (outside) and came along to support us, raising nearly £1,087 for church funds. Thank you to all those who supported this event.

Church fabric, building and churchyard

Our church architect Richard Lamb RIBA AABC, conducted the church's last Quinquennial Inspection in June 2018. The architect's report noted that the church was in a fair condition, and did not highlight any significant matters requiring urgent attention. However, he recommended that the PCC address the residual damp issue through the installation of French drains as soon as possible (hence fundraising effort, see above), and to continue to undertake routine maintenance.

It did not prove possible to commence any project work due to Covid. We are expecting to carry out repairs to two areas of the church roof within a few months, and also to re-point gaps in the stonework within 1 metre of the ground, all round the church. The latter will reduce the damp in the building.

Garren Services (Tracy Knights) continued to mow and strim the churchyard and green burial space in accordance with the grassland management plan recommended by the charity Caring for God's Acre⁷. Visitors often comment positively on the 'well cared for' feel of both the church building and the churchyard.

Financial review

Total incoming resources were £27,080, 26% higher than the first pandemic year in 2020. Total receipts on unrestricted funds were £26,309, of which £17,828 came from voluntary donations, and £3,927 from recovered Gift Aid and the Gift Aid Small Donations Scheme. Total tax-efficient planned giving through the Parish Giving Scheme and by standing order declined by 2% to £11,561. The PCC is grateful for all donations yet, during a year of continued coronavirus pandemic restrictions, wishes to recognise with particular thanks those who chose to give in a planned way.

These steady commitments kept the mission and ministry of the church alive. As services in church gradually resumed, collections bounced back from their 2020 low to £2,311 in 2021.

Total expenditure amounted to £23,296 in 2021, 5% higher than in 2020. Despite COVID-19, the PCC was pleased to be able to honour its Parish Offer commitment of £15,000. This was to ensure that the St Weonards benefice was able to make a realistic contribution towards the cost of its stipendiary ministry, knowing that weaker finances in some neighbouring parishes meant they could not offer as much as they wished to. Insurance cover continued to be provided through Trinitas Church Insurance Services, with the premium increasing by 3.8% to £2,032. The PCC made charitable gifts to support Christian mission totalling £2,250, being 10.3% of unrestricted voluntary income (2020: 12.0%).

Overall, receipts exceeded payments by £3,784 in the year (2020: net payments of £698), represented by a net surplus of £4,123 in unrestricted funds, and a deficit of £(339) in restricted funds. Total PCC funds carried forward at year-end increased 11% to £37,915, a significant portion of which will need to be used to meet the costs of the recommended Quinquennial Inspection repair works.

Reserves policy

It is PCC policy to aim to maintain a balance on unrestricted funds which equates to approximately six months' unrestricted payments, equivalent to around £12,000. It is held to smooth out fluctuations in cash flow, to meet emergencies, and to ensure that Parish Offer contributions can be paid in full on time. The cash balance of £20,444 held in general unrestricted funds at year-end comfortably exceeded this target. A further £1,962 was assigned to a designated fund intended to contribute towards the installation of French drainage around the church in future. The balance in restricted funds was £509. All these funds will be used to further the ministry of the church within and beyond the parish in future years, as well as to meet ongoing repair costs. The 2018 Quinquennial Inspection report from our church architect recommended works totalling at least £26,000, and the PCC expects to carry out some urgent repairs to the fabric in 2022.

The PCC's policy is to invest surplus short-term current account balances in interest-earning accounts such as the CCLA CBF Church of England Deposit Fund or the CAF Bank Gold account. Other surpluses that can be invested over the medium to long-term are invested in the CBF Church of England Investment Fund.

Structure, governance and management

The Parochial Church Council is a corporate body established by the Church of England (PCC Powers Measure 1956, Church Representation Rules 2011). The PCC is currently excepted by order from registering with the Charity Commission.

The PCC operates under the Parochial Church Council Powers Measure. The method of appointment of PCC members is set out in the Church Representation Rules. At St. Weonards, the membership of the PCC consists of the incumbent, churchwardens, and members elected by those members of the congregation who are on the electoral roll of the church. Church of England regulations require that a new electoral roll is drawn up every six years; this was done in 2019. All those who attend our services regularly are encouraged to register on the electoral roll and stand for election to the PCC.

The PCC members are responsible for making decisions on all matters of general concern and importance to the parish including deciding on how the funds of the PCC are to be spent. It is our aim to ensure that new members receive initial training into the workings of the PCC.

The full PCC met four times during the year including the APCM, with an average attendance level of 68%. The UK & overseas mission sub-committee is responsible to the PCC; minutes of its decisions are received by the full PCC and discussed as necessary.

Readers of this annual report should also note that the St Weonards Old School Religious Education Fund was established by The Diocese of Hereford (Educational Endowments) Order 1998 under statutory instrument number 1334, the trustees being the vicar and churchwardens of St Weonards. This Fund is entirely separate from the PCC's financial statements, but is deemed to be connected to St Weonards PCC due to the vicar being chair of both boards. The trustees of this Religious Education Fund "shall apply the income, and may apply the capital thereof, for educational purposes related to the Parish of St. Weonards in connection with the provision of religious education in accordance with the tenets of the Church of England by means of a Sunday School or otherwise."

Administrative information

St. Weonard's Church is situated in the heart of St. Weonards village. It is part of the St Weonards benefice within the deanery of Ross & Archenfield in the Diocese of Hereford.

Respective responsibilities of trustees and examiner

The Parochial Church Council of the Parish of St Weonards Notes to the Accounts for the year ended 31 December 2021

1. Accounting Policies

(a) Basis of accounting

The financial statements of the PCC have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts & Payments basis.

(b) Fund accounting

Unrestricted general funds represent the income funds of the PCC that are not subject to any restrictions as to their use and are available for application on the general purposes of the PCC.

Designated funds are general funds set aside by the PCC for use in the future and are designated for particular projects for administration purposes only. Designated funds remain unrestricted and the PCC may move any surplus to other general funds.

Restricted funds represent a) income from endowments that is to be expended only for the restricted purposes intended by the donor, and b) revenue donations or grants for a specific PCC activity intended by the donor. Where these funds have unspent balances, interest on any pooled investment is apportioned to the individual funds on an average balance basis.

The details of the funds held with restrictions are provided in note 2.

Endowment funds are funds where the capital must be retained either permanently or at the PCC's discretion; the income from the endowment is to be used either as restricted or unrestricted income funds depending on the initial purpose of the endowment.

(c) Incoming resources

The financial statements include all transactions for which the PCC is responsible in law. They do not include the financial statements of church groups that owe their main affiliation to another body. All incoming resources are accounted for gross.

Voluntary income

- Collections are recognised when received by or on behalf of the PCC.
- Planned giving receivable under pledge is recognised only when received.
- Income tax recoverable on Gift Aid donations is recognised when repayments are made by HMRC.
- Grant and legacies are recognised when the PCC is entitled to the use of the resources, their ultimate receipt is considered certain and the amounts due are readily quantifiable.
- Funds raised from church events are accounted for when received.

Income from investments

Dividends and interest is recognised when received.

(d) Resources expended

Grants

Grants and donations are accounted for when paid over.

Activities directly relating to the work of the Church

• Parish Offer contributions towards the Diocese's 'Common Fund' for mission and ministry are accounted for when paid.

Church running expenses

• Insurance premiums are accounted for when paid, which are typically pre-payments for the following financial year.

(e) Fixed assets

Consecrated and benefice property is not included in the accounts in accordance with s.10(2)(a) and (c) of the Charities Act 2011.

Fixed asset investments are shown at cost at year-end as Receipts & Payments accounts do not require the annual revaluation of fixed asset investments. However, the market value of the PCC's investments is reported in note 10 for information.

(f) Current assets

Short-term deposits include cash held on deposit either with the CBF Church of England funds managed by CCLA or at CAF Bank.

2. Designated and Restricted Funds

In 2016, the PCC assigned the donations raised through the Hereford Half Marathon fund-raising event to a **designated** fund for the proposed French drainage project.

The PCC's **restricted** funds exist for the following purposes:

Building

• This fund enables specific donations to be given to support major works to the structure or fabric of the building.

Churchyard

• This fund enables specific donations to be given to support the upkeep of the churchyard and burial grounds.

Drainage

• This fund enables specific donations to be given towards the proposed French drainage project around the church building.

10. Fixed asset investments

The PCC invested £5,000 on 19 July 2016 and a further £10,000 on 5 October 2021 in the CBF Church of England Investment Fund, funded by transfers from its CBF Deposit Fund.
