

# The Parochial Church Council of the Parish of St. Weonards 2024 Report & Accounts

#### Aim and purposes

St. Weonards Parochial Church Council (PCC) has the responsibility of cooperating with the incumbent in promoting in the parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical. The PCC is also responsible for the maintenance of the church and churchyard at St Weonards.

#### **Objectives and activities**

The primary object of the PCC is the promotion of the Gospel of our Lord Jesus Christ according to the doctrines and practices of the Church of England. The PCC is committed to enabling people to worship at our church, and to become part of our parish community. Our services and worship seek to put the Christian faith into practice through prayer, scripture, music and sacrament.

When planning activities we consider the Diocesan focus: encouraging people to live out their faith by sharing God's love in our community and the world through:

- worshipping God and praying for His help and guidance;
- caring and serving people in all life's situations;
- recognising and responding to those in need;
- inspiring and learning through each other's strengths and gifts;
- working to safeguard the integrity of creation

To facilitate this work it is important that we maintain the fabric of St. Weonards Church.



#### **Achievements and performance**

#### **Context**

St Weonards benefice was suspended from 15 May 2021 for a period of two years, to allow the Ross & Archenfield Deanery leadership team to develop a deanery pastoral plan. In July 2022, the Bishop and the Archdeacon decided that, although the Rural Deanery had not completed the Deanery Plan, the post of Priest-in-Charge of the St Weonards Benefice should be advertised.

After two unsuccessful rounds of advertising, a selection panel comprising the diocesan bishop, Archdeacon of Hereford, and parish representatives was assembled, and they were unanimous in endorsing one candidate. We were delighted that on 1 July 2024 Bishop Richard Jackson installed and licensed Reverend Angie Kateley as Priest-in-Charge of the St Weonards group of parishes.

#### **Developing Vocations**

Our All-Age service leader, Alex Mynors Herbert, has continued her third year of ordination training through the part-time course offered by the Cuddesdon-Gloucester-Hereford partnership, which has involved weekly lectures in Ludlow on Wednesday evenings, and twice-termly weekend residential courses at Cuddesdon Theological College near Oxford.

#### Worship and prayer

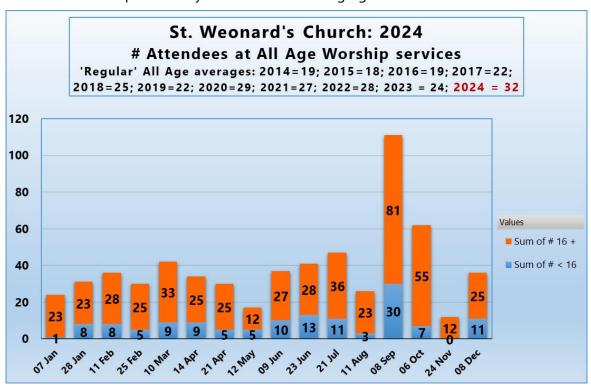


We have continued to hold lay-led All-Age Worship services at 10.00am on the second and fourth Sunday of each month. (In the second half of the year, these moved to the earlier time of 9.30am to allow our new vicar time to officiate at another service in the benefice, after celebrating communion.) We were delighted to welcome worshippers from across the benefice beyond. Attendance peaked September for a baptism and communion (81 adults + 30 children and young people + 2 online). Average attendance across the year excluding services with baptism or confirmation reached its highest level in a decade of 32 (25 adults + 7.5 children and young people). We have continued to stream most of our All Age services live via Zoom, which has been greatly

improved following the upgrade to the church's audio system in spring 2024.

Twelve of our services during the year were with Holy Communion, and the PCC is particularly grateful to visiting officiants at all our services during the interregnum, who in first half of 2024 included Archdeacon Derek Chedzey (three times); Rural Dean Sheila Anthony (twice); and Revd Julian Reindorp for Good Friday, Easter Day and another Sunday in April.

An important aspect of these occasions is the opportunity to enjoy fellowship after the services with delicious refreshments provided by members of the congregation.



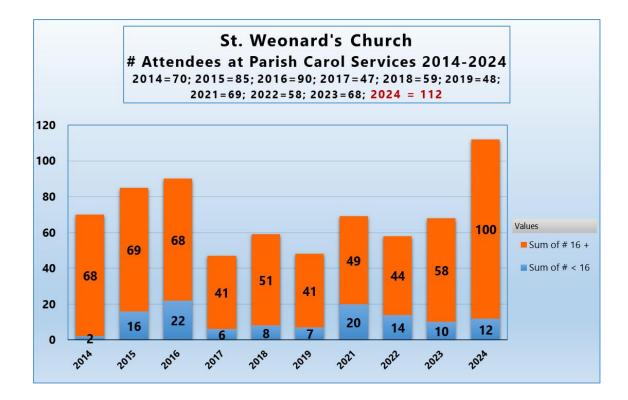
It was a great pleasure to welcome the friends and families of children who were baptised in the church: Nancy Thornley and Elizabeth Phillips.

Family and friends came in October to remember and give thanks for the life of Melanie Rix.

- Remembrance Sunday (30 + 4)
- Parish carol service (100 + 12)
- Christmas Eve crib service (71 + 50)
- Christmas Eve 'midnight' communion, (43 + 3).





There has also been a small group meeting each month to pray for our benefice, churches and local communities.

#### Caring & serving and responding to community needs

We have continued to make collections for the Hereford Food Bank.

#### Safeguarding the integrity of creation

As a church, we seek to respond to the fifth Anglican 'mark of mission', to 'strive to safeguard the integrity of creation and sustain and renew the life of the earth.' Following our **Eco Church**<sup>1</sup> bronze award in 2020, we have continued to try to work out and integrate the core themes (Worship & Teaching, Buildings, Land, Community & Global Engagement, and Lifestyle) into our common life as a church.

#### Safeguarding

The PCC has adopted the Church of England's 'Promoting a Safer Church: Safeguarding Policy Statement', and ensures that safeguarding is a standing order agenda item at every meeting. We are grateful to our Parish Safeguarding Officer (PSO), Fiona Mynors, for her work in this key area. The PCC considers that it has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016 to have regard to the House of Bishops' guidance on safeguarding children and vulnerable adults. St Weonards PCC has adopted key features that help maintain a safer culture that protects and promotes the welfare of children, young people and vulnerable adults. All PCC members completed National Safeguarding Foundations (C1) refresher training in January 2025. In addition, the PSO has completed the Safeguarding Leadership training.

#### **Deanery & Diocesan Synod**

We thank Richard Mynors for acting as our deanery and diocesan synod representative, also Christine Lewis for taking over as Deanery rep. This role provides an important link between the parish and wider church structures. The Deanery is to re-advertise in early 2025 for a 'LifeLink Chaplain' to work with young people, mainly through John Kyrle High School. We are grateful to Revd Sheila Anthony for her continued support and guidance as Rural Dean, and particularly for her oversight of our benefice during the vacancy period.

#### **Supporting Christian mission and ministry**

We aim to share God's love in our community and the world and show Jesus Christ to those around us in practical ways through tithing, aiming to give at least 10% of our voluntary income to mission work outside the parish. Our principle is to give to Christian organisations working at diocesan, national and international levels. In 2024, the PCC made gifts of:

- £750 to Borderlands Rural Chaplaincy<sup>2</sup> which provides a confidential listening ear offering pastoral support to farmers, farming families and agricultural communities;
- £100 to the Herefordshire Historic Churches Trust<sup>3</sup>;
- £750 to Church Urban Fund<sup>4</sup> which tackles complex challenges like poverty and exclusion across England by mobilising people, churches, and whole communities to make a positive difference;
- £750 to the Church Mission Society<sup>5</sup> to support Rev'ds Simon and Sarah Cawdell serving in Gulu in northern Uganda.

#### **Ecumenical relationships**

The ecumenical opportunities of linking with neighbouring Baptist and Methodist Churches have been limited in 2024, although we have continued to welcome families from these congregations to our All-Age services, and pray with those who would associate themselves with non-Anglican denominations.

#### **Fundraising events**

The PCC is very grateful to all who supported a variety of events through the year:

- the Open Gardens event on 2 June at Treago, generating £1,931 for general church funds;
- the Wild Arts production of *The Magic Flute* on 7 June at Treago which resulted in a distribution of £4,000 from the Herefordshire Historic Churches Trust;
- the Harvest Festival service and supper on 25 October which raised £645 for We Are Farming Minds, and prize draw which made £101 for the church's audio-visual project; and
- 'Faye's Bingo' evening on 29 November in the Village Hall which raised a wonderful £1,451 in aid of the Churchyard Fund.

The PCC also received £17 from Easyfundraising through donors choosing to donate to the PCC via their online shopping.

#### Grants

The PCC is grateful to the Herefordshire Historic Churches Trust (HHCT) for sharing half the net proceeds from the Wild Arts event at Treago in June, resulting in a £4,000 grant for general church funds.

The PCC also received a £4,000 grant from the Hereford Diocese's 'Mustard Seed Fund', and a similar sum from the St Weonards Religious Education Fund, in aid of the church's audio-visual project.

The UK Government's Listed Places of Worship (LPW) Grant Scheme made a grant of £1,213 to the PCC

equivalent to the VAT incurred on re-pointing the external masonry of the church.



#### Fabric report - building and churchyard

Deborah Johnson RIBA of Hook Mason & Co had undertaken the Quinquennial Inspection of the church on 21 November 2023, noting that the church was clearly very well cared for, but observed that ongoing problems with damp in the tower and the NE corner of the church were mainly attributable to discharges of rainwater. To help mitigate this, the PCC commissioned Muldowney & Sons to complete the repointing of exterior masonry above the damp line around the building.



Following List B approval from the Archdeacon of Hereford, the PCC commissioned Distributed Sound & Video Ltd ("DSAV") to install and commission a replacement audio system<sup>6</sup> for which they had quoted in November 2023. The team from DSAV completed their work on schedule and the PCC was particularly pleased with the careful finish of the speaker units and wiring to match closely the surrounding stonework. The new equipment enables excellent



sound reproduction in the building and online from fixed and roving microphones, and straightforward controls from a unit at the back of the nave or from a tablet app.

Garren Services (Tracy Knights) continued to mow and strim the churchyard and green burial space in accordance with the grassland management plan recommended by the charity Caring for God's Acre <sup>7</sup>. Visitors often comment positively on the 'well cared for' feel of both the church building and the churchyard.

#### **Financial review**

**Total incoming resources** were £52,796, 20% higher than in 2023. Total receipts on unrestricted funds were £41,083 (+15% vs 2023), of which £20,681 came from voluntary donations (2023: £19,044), and £4,987 (2023: £5,475) from recovered Gift Aid and the Gift Aid Small Donations Scheme. Total tax-efficient planned giving through the Parish Giving Scheme and by standing order increased by 8% to £14,327 (2023: +5% to £13,307). The PCC is very grateful for all donations and wishes to recognise with particular thanks those who chose to give in a planned way. These steady commitments keep the mission and ministry of the church alive, and underpin the PCC's contributions to the diocesan Common Fund to pay for our clergy.

The value of collections taken during church services varies significantly depending on the number and type of service: the total of service collections in 2024 was £1,731 (2023: £2,253). Additionally, in 2024, the PCC received a very generous pecuniary legacy of £5,000 from Richard Matthews, and the PCC is most grateful to the Matthews family for their kind support.

The PCC also wishes to thank all those who supported fund-raising events for the church, which generated £3,500 (2023: £6,520). The annual fête in the grounds of Treago Castle in June raised £1,931, while the ever-popular 'Faye's Bingo' made £1,451 (2023: £1,551) for the Churchyard Fund.

In 2024, the PCC received one-off grants totalling £14,213 (2023: £8,592). These were:

- £4,000 from St Weonards Religious Education Trust towards the church's audio-visual project;
- £4,000 from Herefordshire Historic Churches Trust, being 50% of the net proceeds from the Wild Arts' Magic Flute production at Treago Castle on 7 June;
- £4.000 from the Hereford Diocesan Board of Finance's 'Mustard Seed Fund' towards phase 2 of the church's audio-visual project;
- £1,213.20 from the Department of Culture, Media & Sport's Listed Places of Worship scheme reimbursing VAT incurred on church building works within the previous 12 months;
- £1,000 from the St Weonards Group account, being a re-distribution of surplus funds.

**Total expenditure** in 2024 was £49,533 (2023: £39,816), which included one-off capital repairs to the church building of £2,909 (2023: £14,208) plus £16,778 on the replacement audio system including renewal of the deaf loop in the front section of the nave.

The PCC was pleased to be able to honour its Parish Offer commitment of £17,500, a 5.4% increase on 2023. This was to ensure that the St Weonards benefice was able to make a realistic contribution towards the cost of its stipendiary ministry. Insurance cover continued to be provided through Trinitas Church Insurance Services, with the premium increasing by 2.1% to £2,354.

The PCC made charitable gifts to support Christian mission totalling £2,350 (2023: £2,150), being 9.2% of unrestricted voluntary income<sup>8</sup> (2023: 8.8%).

Overall, receipts exceeded payments by £3,263 in the year (2023: net receipts of £4,221), represented by a net deficit of £(1,762) in unrestricted funds, and a surplus of £5,025 in restricted funds. Total PCC funds carried forward at year-end increased by 8% to £45,135 (2023:  $\pm$ 11% to £41,872), of which approximately a fifth will be invested in phase two of the audio-visual upgrade project.

#### **Reserves policy**

It is PCC policy to aim to maintain a balance on unrestricted funds which equates to approximately six months' regular unrestricted payments, equivalent to around £15,000. It is held to smooth out fluctuations in cash flow, to meet emergencies, and to ensure that Parish Offer contributions can be paid in full on time. The cash balance of £17,387 held in general unrestricted funds at year-end

exceeded this target by 16%, in anticipation of above average levels of expenditure in 2025-26. The balance across three restricted funds was £12,748 (2023: £7,723), split £5,568 Audio-Visual Fund, £3,500 Bell Maintenance & Restoration Fund, £675 Building Fund, and £3,005 Churchyard Fund. All these funds will be used to further the ministry and outreach of the church in future years, as well as to meet ongoing repair costs.

The PCC's policy is to invest surplus short-term current account balances in interest-earning accounts such as the CCLA CBF Church of England Deposit Fund or the CAF Bank Gold account. Other surpluses that can be invested over the medium to long-term are invested in the CBF Church of England Investment Fund.

#### Structure, governance and management

The Parochial Church Council is a corporate body established by the Church of England (PCC Powers Measure 1956, Church Representation Rules 2011). The PCC is currently excepted by order from registering with the Charity Commission.

The PCC operates under the Parochial Church Council Powers Measure. The method of appointment of PCC members is set out in the Church Representation Rules. At St. Weonards, the membership of the PCC consists of the incumbent, churchwardens, and members elected by those members of the congregation who are on the electoral roll of the church. Church of England regulations require that a new electoral roll is drawn up every six years; this was last done in 2019. All those who attend our services regularly are encouraged to register on the electoral roll and stand for election to the PCC.

The PCC members are responsible for making decisions on all matters of general concern and importance to the parish including deciding on how the funds of the PCC are to be spent. It is our aim to ensure that new members receive initial training into the workings of the PCC.

The full PCC met five times during the year including the APCM. The UK & overseas mission sub-committee is responsible to the PCC, but did not meet separately during 2024, as all charitable giving decisions were made by the PCC as a whole.

Readers of this annual report should also note that the St Weonards Old School Religious Education Fund was established by The Diocese of Hereford (Educational Endowments) Order 1998 under statutory instrument number 1334, the trustees being the vicar and churchwardens of St Weonards. This Fund is entirely separate from the PCC's financial statements, but is deemed to be connected to St Weonards PCC due to the vicar being chair of both boards. The trustees of this Religious Education Fund "shall apply the income, and may apply the capital thereof, for educational purposes related to the Parish of St. Weonards in connection with the provision of religious education in accordance with the tenets of the Church of England by means of a Sunday School or otherwise."

In 2024, the Education Fund made a grant of £4,000 to St Weonards PCC towards its Audio-Visual project, £416 to Out of the Box for training materials to be used by the new vicar, £49 for Action Bibles for St Weonards Primary School Year 6 leavers, £47 for child baptism resources, and £60 for choral sheet music used by the benefice choir at Christmas services.

St. Weonard's Church is situated in the heart of St. Weonards village. It is part of the St Weonards benefice within the deanery of Ross & Archenfield in the Diocese of Hereford.

# The Parochial Church Council of the Parish of St Weonards Notes to the Accounts for the year ended 31 December 2024

#### 1. Accounting Policies

#### (a) Basis of accounting

The financial statements of the PCC have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts & Payments basis.

#### (b) Fund accounting

*Unrestricted general funds* represent the income funds of the PCC that are not subject to any restrictions as to their use and are available for application on the general purposes of the PCC.

Designated funds are general funds set aside by the PCC for use in the future and are designated for particular projects for administration purposes only. Designated funds remain unrestricted and the PCC may move any surplus to other general funds.

Restricted funds represent a) income from endowments that is to be expended only for the restricted purposes intended by the donor, and b) revenue donations or grants for a specific PCC activity intended by the donor. Where these funds have unspent balances, interest on any pooled investment is apportioned to the individual funds on an average balance basis.

The details of the funds held with restrictions are provided in note 2.

Endowment funds are funds where the capital must be retained either permanently or at the PCC's discretion; the income from the endowment is to be used either as restricted or unrestricted income funds depending on the initial purpose of the endowment.

#### (c) Incoming resources

The financial statements include all transactions for which the PCC is responsible in law. They do not include the financial statements of church groups that owe their main affiliation to another body. All incoming resources are accounted for gross.

#### **Voluntary income**

- Collections are recognised when received by or on behalf of the PCC.
- Planned giving receivable under pledge is recognised only when received.
- Income tax recoverable on Gift Aid donations is recognised when repayments are made by HMRC.
- Grant and legacies are recognised when the PCC is entitled to the use of the resources, their ultimate receipt is considered certain and the amounts due are readily quantifiable.
- Funds raised from church events are accounted for when received.

#### **Income from investments**

Dividends and interest is recognised when received.

#### (d) Resources expended

#### Grants

Grants and donations are accounted for when paid over.

#### Activities directly relating to the work of the Church

• Parish Offer contributions towards the Diocese's 'Common Fund' for mission and ministry are accounted for when paid.

#### **Church running expenses**

 Insurance premiums are accounted for when paid, which are typically pre-payments for the following financial year.

#### (e) Fixed assets

Consecrated and benefice property is not included in the accounts in accordance with s.10(2)(a) and (c) of the Charities Act 2011.

Fixed asset investments are shown at cost at year-end as Receipts & Payments accounts do not require the annual revaluation of fixed asset investments. However, the market value of the PCC's investments is reported in note 10 for information.

#### (f) Current assets

Short-term deposits include cash held on deposit either with the CBF Church of England funds managed by CCLA or at CAF Bank.

#### 2. Designated and Restricted Funds

In 2016, the PCC assigned the donations raised through a Hereford Half Marathon fund-raising event to a **designated** fund for the proposed French drainage project. The name of this designated fund has been amended subsequently to **Damp Management** to reflect a broader range of damp reduction measures in and around the church including lime mortar re-pointing.

The PCC's **restricted** funds exist for the following purposes:

#### **Bell Maintenance & Restoration**

• The Bell Maintenance & Restoration Fund for St Weonard's Church was created in April 2022 following receipt of a legacy from the late Mr E W (Bill) Taylor. This pecuniary gift of £1,000 was shared equally between the parish churches of Garway, Orcop, and St Weonards. The PCC received a further £3,500 pecuniary legacy from Bill Taylor's estate in November 2022, for the installation of a training dumbbell in St Weonard's Church. (Any surplus from this legacy after installation of the dumbbell may be used for the general ecclesiastical purposes of St Weonards PCC.) Matthew Higby & Company Ltd <sup>9</sup> have confirmed in January 2025 that they have a training dumbbell in stock and intend to supply and install it in the spring.

#### **Building**

 This fund enables specific donations to be given to support major works to the structure or fabric of the building.

#### Churchyard

• This fund enables specific donations to be given to support the upkeep of the churchyard and burial grounds.

#### 10. Fixed asset investments
